#### PREA Standard 115.388

The Prison Rape Elimination Act (PREA) was established to address sexual abuse and sexual harassment of persons confined to correctional facilities. Standard 115.388 Data Review for Corrective Action of PREA, requires that all public and private institutions that housed adult or juvenile offenders review data collected and aggregated on an annual basis in order to assess and enhance the effectiveness of its sexual abuse prevention, detection and response policies, practices and training, including identifying problem areas; taking corrective action on an ongoing basis; and preparing an annual report of its findings and corrective actions for each facility as well as the agency as a whole.

Christian Acres Youth Center contracts with the Louisiana Office of Juvenile Justice to house their youth. The facility accepts youth for placement from all areas of the state.

### **Key Terms and Definitions**

**NONCONSENSUAL SEXUAL ACTS** – Unwanted contact with another resident or any contact with staff that involve contact with the penis and the vagina or anus; contact between the mouth and the penis, vagina, or anus; penetration of the anal or vaginal opening of another person by a hand, finger, or other object; and rubbing of another person's penis or vagina by a hand.

**ABUSIVE SEXUAL CONTACTS** – Unwanted contact with another resident or any contact with staff that involved touching of the residents' buttocks, thighs, penis, breasts, or vagina in a sexual way.

**SEXUAL HARASSMENT** – Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one resident directed toward another.

**STAFF SEXUAL MISCONDUCT** —All incidents of willing and unwilling sexual contact with facility staff, and all incidents of sexual activity that involved oral, anal or vaginal penetration.

**STAFF SEXUAL HARRASMENT**- Repeated verbal comments or gestures of a sexual nature to a resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

ALLEGED-accused but not proven.

SUBSTANTIATED- provide evidence to support the truth

The agency shall impose no standard higher than *a preponderance of the evidence* in determining whether allegations of sexual abuse or sexual harassment are **substantiated**.

**PREPONDERANCE OF EVIDENCE**- prove that there is a greater than 50% chance, based on all the reasonable evidence, that the allegation occurred.

## 2017-2018 Comparison of PREA Allegations

This report includes a comparison for the calendar years of 2017 and 2018data on sexual abuse and sexual harassment allegations and provides an assessment of Christian Acres Youth Center's progress in preventing sexual abuse and sexual harassment of its residents. This review included a review of the data from all available incident reports, grievances and investigations.

### **Comparative Analysis:**

Christian Acres Youth Center had changes in the categories of reported allegations from 2017-2018. The changes in the categories are from 7 total alleged allegations in 2017 to 4 total alleged allegations in 2018. In 2017 CAYC experienced an decrease in residents admitted from 209 in 2017 to 166 in 2018. There was decrease in allegations with 7 reported in 2017 and 4 reported in 2018. Based on these numbers the per capita of allegations in 2017 was 3.3% and the per capita of allegations in 2018 was 2.4%, which constitutes a decrease.

Christian Acres Youth Center continues its efforts in ensuring that the residents, staff, volunteers and contractors are educated in the agency's Zero Tolerance policy. Any suspicions based on the attached continuum are documented and/or investigated to ensure the health and safety of the residents served. A comparative analysis, based on the definitions in this report, of 2017 and 2018 data indicates the following:

- There is a **decrease** of reported resident-on-resident NONCONSENSUAL SEXUAL ACTS. In 2017 there is 2 reported and in 2018 there is 1 reported.
- There is a **decrease** of reported resident-on-resident ABUSIVE SEXUAL CONTACT. In 2017 there is 2 reported and in 2018 there is 1 reported.

- There is a **decrease** of reported resident-on-resident SEXUAL HARASSMENT. In 2017 there is 1 reported and in 2018 there is 0 reported.
- There is an increase of reported STAFF SEXUAL MISCONDUCT. In 2017 there is 0 allegations reported and in 2018 there is 2 reported.
- There is No change of reported STAFF SEXUAL HARRASMENT. In 2017 & 2018 there is 0 reported.

#### 2017 Corrective Actions

- Training noting the significance of documenting incidents and prevention of incidents was held on 03/20/17 with the emphasis on residents who are on precautions and the importance of supervision during bathroom and shower procedures.
- New signs were placed in the gym regarding monitoring the bathroom during the school, as well
  as keeping the bathroom door locked at all times. The teachers who are employed with the
  Madison Parish School Board were made aware that they were not responsible for opening the
  bathroom for the residents. Only CAYC staff members are to open the bathroom doors for
  residents to assure the proper monitoring.
- CAYC launched an on-line training program for all staff in March 2017. This has assured that all staff receive the information needed in order to provide for the residents' overall safety.
- In August 2017 CAYC launched the data base system. Information is easily accessed for review as well as monitoring any possible retaliation for reports made.
- October 2017 the Suicide Prevention Plan: Suicide, Runaway and Safety Precautions Policy and Procedures was revised and implemented. A course in Lessonly was rolled out to all employees to explain the procedures.

#### **2018 Corrective Actions**

- New procedures regarding resident placement in the cottage and any bedroom movement have been put into place. All movements and placements must go though the PREA Coordinator. A new form is listed in the data base system.
- Bedtime procedures now include the televisions and game systems to be turned off at resident's bedtime and cannot be turned on until midnight (if all residents are asleep).
- Utilizing the Dianna Screening tool, which is a child abuse risk reduction too, was considered and may be implemented in the future.
- On October 1, 2018, CAYC was required to submit a request for all owners including board members, contractors, and all staff (paid, non-paid, and volunteers) employed/providing services as of October 1, 2018, to Licensing management staff for state central registry for Child Abuse and Neglect. (This was done in lieu of the Dianna Screening at this time.)
